I write to congratulate the Review Panel on completion of 'Phase 1 Review into the Treatment of Women in the Australian Defence Force' and the publication of your *Report on the Review into the Treatment of Women in the Australian Defence Force Academy*.

The treatment of women in the Australian Defence Force is a crucial matter at this time, requiring strong leadership and expertise to identify pathways for improvement. I commend the approach of the Review Panel in conducting research and formulating recommendations for the Australian Defence Force. The Phase 1 Report highlights the significant improvements that have been achieved over the last two decades as well as the need for further structural and cultural change across the Defence Force.

In regards to 'Phase 2: Review into the Treatment of Women in the Australian Defence Force' and the development of cultural change strategies in particular, I would like to draw your attention to some recent VicHealth research and development activity that has consolidated the evidence-base for developing safe, respectful and inclusive environments for women and girls. This work is of particular relevance for the Terms of Reference specified in Phase Two:

- The effectiveness of the cultural change strategies recommended by the Chief of the Defence Force Women's Reference Group in the Women's Action Plan including the implementation of these strategies across the Australian Defence Force;
- Measures and initiatives required to improve the pathways for increased representation of women into the senior ranks and leadership of the Australian Defence Force; and
- Any other matters incidental to the terms of reference such as sexual harassment, sexual abuse and unacceptable behaviour.

VicHealth utilises a public health framework to promote health with a particular focus on mental health and wellbeing. Our work is focussed on the social determinants of health which are best addressed in mainstream settings such as workplaces, organisations, corporate and community services. Our research and development activity provides a comprehensive evidence-base regarding the most effective methodology for organisational development and cultural change, as well as the priority settings and population groups for this work.
